

Fremont County Sheriff's Office
Detention Division - Visitor Regulations and Registration Form

Photo Identification must be submitted with this form.
If you have no form of identification you will not be allowed to visit.

1. All visitors must read, agree to, and sign this visitor registration page. Visitors must have current and valid identification with photograph and date of birth. Children of the inmates or immediate next of kin under the age of 18 may visit if accompanied by their parent or legal guardian. Notes giving permission are not allowed and will not be accepted. The parent or legal guardian must be present at the visitation site during the entire length of the visit. All visitation rules will apply to children as well as adults.
2. Contact visits are not permitted in this facility.
3. Thin strapped tops or shirts, halter-tops, mini-skirts, short shorts, or any other revealing clothing will not be allowed. If noticed by staff members during an approved visit, that visit will be terminated.
4. Visitors bringing in illegal contraband will be subject to prosecution.
5. Only two adult visitors will be allowed in the visitation room at the same time to visit an inmate.
 - i. Each person visiting an inmate will fill out this registration page. Any person who has not turned in a visitor registration page will not be permitted in the visitation room.
6. A visitor may be allowed to make only one visit per day. Each inmate will be permitted only one visit per day.
7. If a visitor has more than one blood relative in this facility at any given time, the visitor may visit each relative on the same day; however, a visitor registration page must be filled out and turned in for each individual. Visitors cannot turn in more than one registration page at a time. After each visit they may then submit the registration form for their next visit. Visits will not be concurrent.
8. No visitor will be permitted to visit if he/she appears to be under the influence of alcohol or drugs.
9. This is a non-smoking facility.
10. All normal visits will be 15 to 30 minutes long and at the discretion of the detention facility.
11. The time in parenthesis next to each block is the cut-off time for visitor registration. No visitor will be allowed to register for a visit after the time stated in parenthesis.
